

## DOE ASSET SCORE ATLANTA INSTRUCTIONS

- 1) Set up a username and password on the login page:
  - <https://buildingenergyscore.energy.gov/>
- 2) Once you are logged in, on the right-hand side, click on the green “Audit Reporting Tool” dropdown menu.
  - Then, select “Other City Report.”
  - Under “Report Type,” choose “Atlanta Report.”
  - Enter the building name and other relevant building data.
- 3) Next, populate the data fields with energy data from the audit report provided by your audit service provider. For guidance on which sections and data fields are required for compliance with Atlanta’s Commercial Building Energy Efficiency Ordinance please see the next section titled “DOE ASSET SCORE REQUIRED SECTIONS FOR ATLANTA.”
- 4) For instructions on each data field, select the “?” logo next to each field. It will take you to a DOE website with detailed instructions relevant to that data field.
- 5) For troubleshooting and questions related to using Asset Score, submit a ticket through their Help Desk (<https://help.buildingenergyscore.com/support/home>). You can also send support requests using the “Help Desk” button on the top-right hand corner of the screen.
